- Experienced in new build projects and pre-delivery inspections on vessels up to 63m of FRP, steel and aluminium construction, constructed throughout Europe and destined for all regions of the World. Vessels under 24m inspected are typically RCD or MCA compliant with larger vessels constructed in accordance with RINA pleasure and commercial rules, Lloyds or MCA LY3 to various red ensign and other popular flag state requirements including Malta commercial vessels.

Identified scope of works and material requirements for repair and replacement. Monitored quality of works throughout and conducted pre-delivery sea trials, systems testing and cosmetic inspections to ensure vessel was returned to full working order. Completed MCA commercial compliance examination process and the vessel has now completed four charter seasons.
